RULES: Current NRA Pistol Rules will govern.

EQUIPMENT: Any safe 22 Caliber Pistol or Revolver (NRA Rule 3.4). Triggers may be weighed and will be weighed if National Records are broken.

TARGETS: NRA B-2, slow fire target, NRA B-3 timed & rapid fire target. Distance: 50 Feet

CLASSIFICATION: The NRA classification system will be used in all matches. Unclassified shooters will fire in the Master class. Classification cards and Temporary Score books will be checked. Assigned classifications may be used (NRA Rule 19.6).

SCORE CARDS: Sectional score cards will be used and **MUST BE SIGNED BY THE COMPETITOR** to be considered for national ranking and awards.

SCORING will be done by match personal.

CHALLENGES: A Challenge fee of 3.00 will be charged for each challenge, to be refunded if upheld. (See Rule 16.1).

EYE and EAR PROTECTION are **MANDATORY**.

ENTRIES: Individual match entries will be made by completing and submitting the attached **ENTRY** form accompanied by the correct fees. Be sure to indicate date and time you wish to fire. Make checks payable to **ROSLYN RIFLE & REVOLVER CLUB**. Return form and fees to **RALPH MARCHESE, 27 BRIDGE LANE, HICKSVILLE, NY 11801**. Entries must be received by **Monday, March 4, 2014**.

TEAM ENTRIES: Team Captain or first team member to fire the match, must complete team entry card. Team fees must be paid prior to firing match. Team members (4) are not required to be squadded as a unit to fire.

ENTRIES LIMIT: Entries are limited to 100 competitors. Post will be accepted if space is available.

FEES: Individual Matches #1 thru 5, 30.00 per competitor (includes 8.00 NRA Registration).

Team Matches 24.00 per team (includes 8.00 NRA Registration).

SQUADDING: Will begin immediately based on earliest postmark and only those entries with complete information and full entry fee will be accepted. If you want to squad several people on the same relay send all forms together or indicate such. Entries will be verified by **E-MAIL** (preferred) or post card. Teams are not required to be squadded together.
