

New York State Indoor Pistol Championship

LOCATION: Roslyn Rifle and Revolver Club Range
1130 Broadway, Westbury, NY 11590

TYPE: Indoor 50ft., 2700 Point NRA Registered Tournament

RULES: NRA pistol rules shall govern.

FIREARMS: Any safe .22 Caliber, Centerfire, and .45 Caliber pistol or revolver.

FEE: A total Individual fee of \$55 per competitor will be charged. Team Matches will be unfired and consist of the National Match Course in each of the .22, CF and .45 matches. Teams of 4 shooters will be charged a total fee of \$12. Make checks payable to: Roslyn Rifle and Revolver Club.

RELAYS: There will be 4 Relays of 10 Shooters each.

Saturday April 7 – Relay #1 8 AM, Relay #2 1:30 PM

Sunday April 8 – Relay #3 8 AM, Relay #4 1:30 PM

All shooters are expected to fire the complete tournament before leaving the line.

Eye and Hearing Protection is MANDATORY. You cannot shoot without it.

The use of ECI's (Empty Chamber Indicators) is mandatory. They will be provided if necessary.

NOTE: The use of jacketed or plated bullets is NOT allowed at the Roslyn R&R range.

ELIGIBILITY: To be eligible for NYS awards, all shooters should be NRA members and all shooters must belong to either the NYSRPA or their home state organization. Membership cards and Classification cards must be presented at the time of registration. Membership applications will be available at the range.

Each competitor will be required to fill out and sign a "Competitor Fact Sheet" to be sent to the NYSRPA Pistol Director. This can be done as part of the registration process on www.NJPistol.com.

STATE AWARDS: Open Winner and/or NYS Champion, 1st High Master, 1st Master, 1st Expert, 1st Sharpshooter, 1st Marksman, High Service/Police, High Grand Senior, High Senior, High Women, High Junior, Open Team Champions, and/or NYS Team Champions, additional team awards if number of entries warrant. NYSRPA will award prizes, within the categories listed above, for scores fired by individuals and teams at this and other ranges holding the NYS Indoor Pistol Championships.

Notice to competitors: The "Final Match Bulletin" (of all locations holding the match) will be sent to each of you via email when it is complete. Please make sure when you fill out the "Competitor Fact Sheet" that you submit your email address legibly as well as all of the other information.
