### Rifle:

NRA Match Rifle , NRA Service Rifle, or NRA Any Rifle. Specific designations of rifle and equipment are outlined in Section 3 of the NRA High Power Rifle rule book available on line. <http://compete.nra.org/documents/pdf/compete/RuleBooks/HPR/hpr-book.pdf>

Caliber Requirements:

No less than .224 cal. and no greater than .30 cal. with exception to "Any Rifle" which may not exceed .35 cal.

Rules: NRA rules will govern all shooters

**START TIME:** Matches start at 9AM. Squadding is at 8:30AM.

**ELIGIBILITY:** Open to all legal gun owners, club & non- club members

**FEES:** Individual match fee is \$20. A one time club fee of \$10 is required for XTC matches to be eligible for awards, the competitor must shoot at least three XTC matches.

**Awards:** Awards for overall league winner and best in each classification, a minimum of four competitors per class, otherwise the lower classification will be combined with the next highest class.

Long Island Expressway going east to Exit 71.

At the end of the off ramp make a left on to Edwards Avenue.

North on Edwards Avenue then left on Mill River Road.

Travel west on Mill River Road just a short distance, there will be two white posts on your left; this is the entrance gate to outdoor range.
